John has a broad civil practice encompassing major areas including public, commercial and corporate law. He had advised on a wide range of commercial matters concerning broadcasting, telecommunications, finance and securities, insurance, shipping, civil fraud, conflict of laws and jurisdiction. John has been actively developing a competition law practice in Hong Kong. In 2015, he acted as junior counsel for the Communications Authority in Hong Kong in a judicial review, in Television Broadcasts Limited v Communications Authority & The Chief Executive in Council, a landmark decision in Hong Kong discussing the general principles of competition provisions and other important issues in competition law proceedings. In January 2016, he was appointed to the Hong Kong Competition Commission's Panel of External Counsel. John has acted in a number of high profile cases such as the Bawang defamation trial, a number of judicial reviews concerning the television broadcasting industry, and a high value Mareva injunction application freezing over €335 million worth of assets. Apart from court litigation, John regularly handles international arbitration matters under the HKIAC/UNCITRAL rules.
